Event Overview

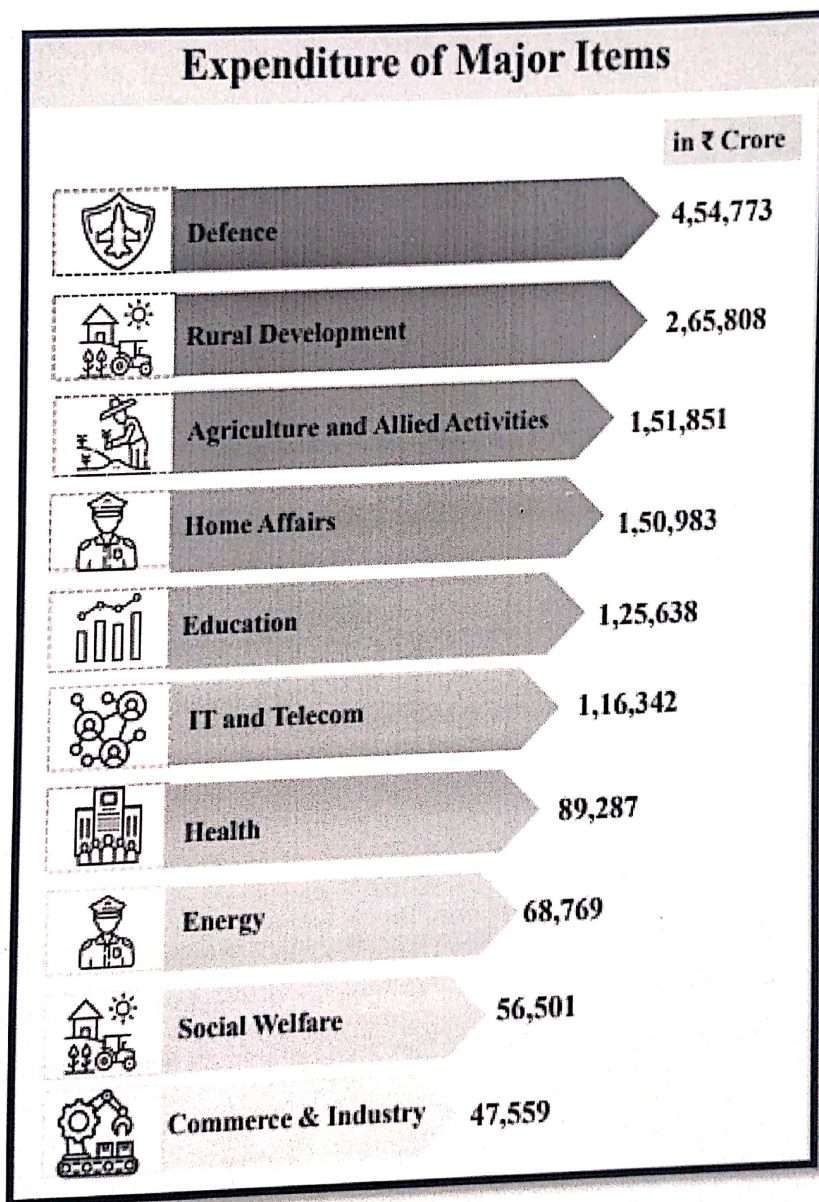

- ⊕ Taxation: Explanation of changes in income tax slabs, corporate tax rates, and other tax-related measures.

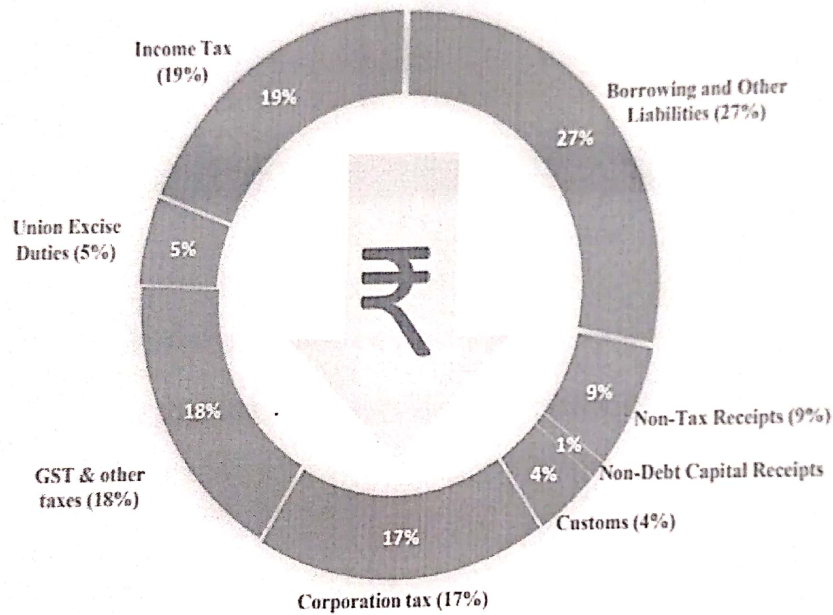


Throughout the discussion, students were encouraged to ask questions and participate actively. The faculty panel provided clear and insightful explanations, fostering a lively and interactive learning environment.

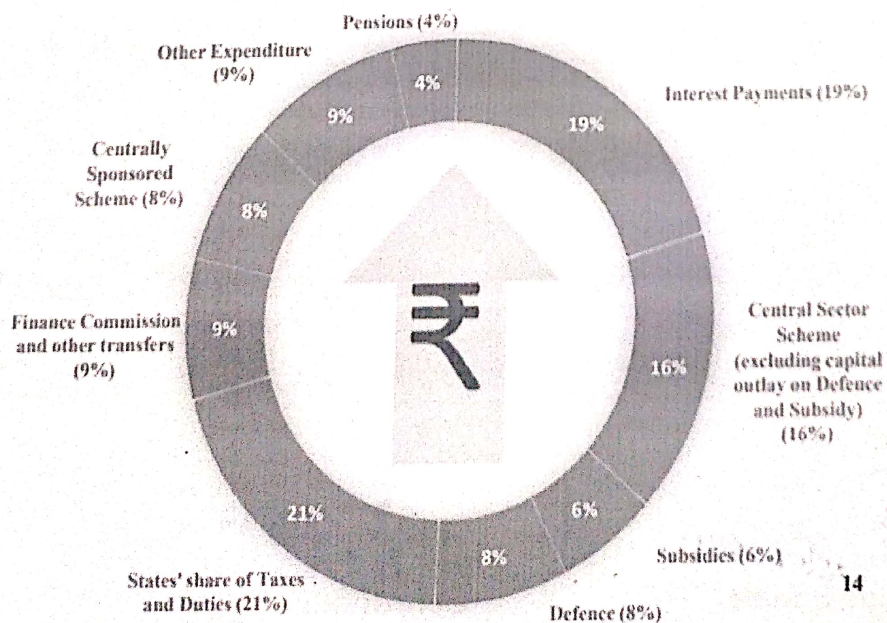
Student Participation

Rupee Comes From

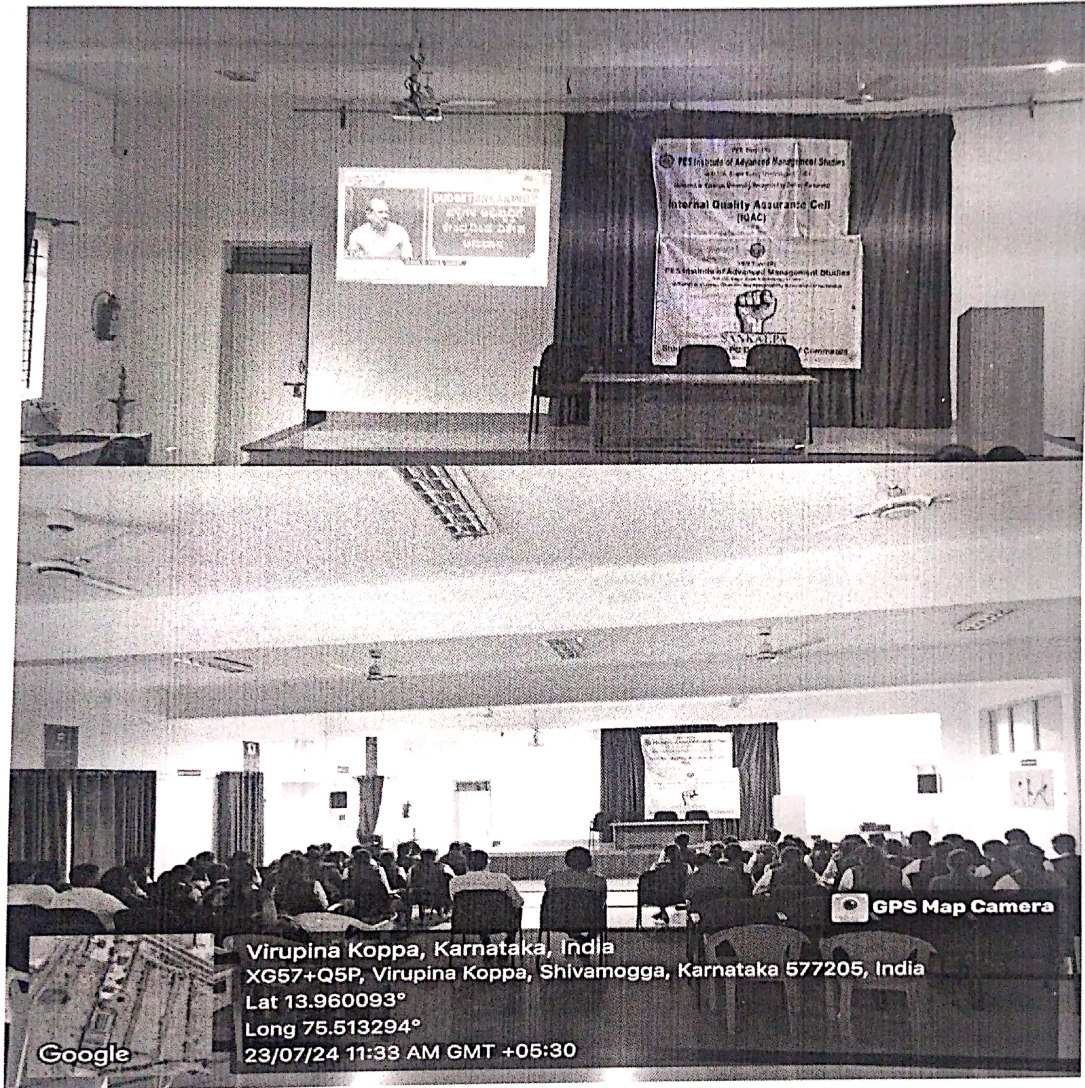


Conclusion
