Union Finance Minister Smt. Nirmala Seetharaman presented the Union Budget 2022-23 on 1st February, 2022 at Lok Sabha. She said that the budget proposal for this Financial Year rest on health and well being, infrastructure and inclusive development, energy transition and climate action, financing of investments and 'Minimum Government and Maximum Governance'. India's Economic growth estimated at 9.2% to be the highest among all large economies. 60 lakh new jobs to be created under the productivity linked incentive scheme in 14 sectors.

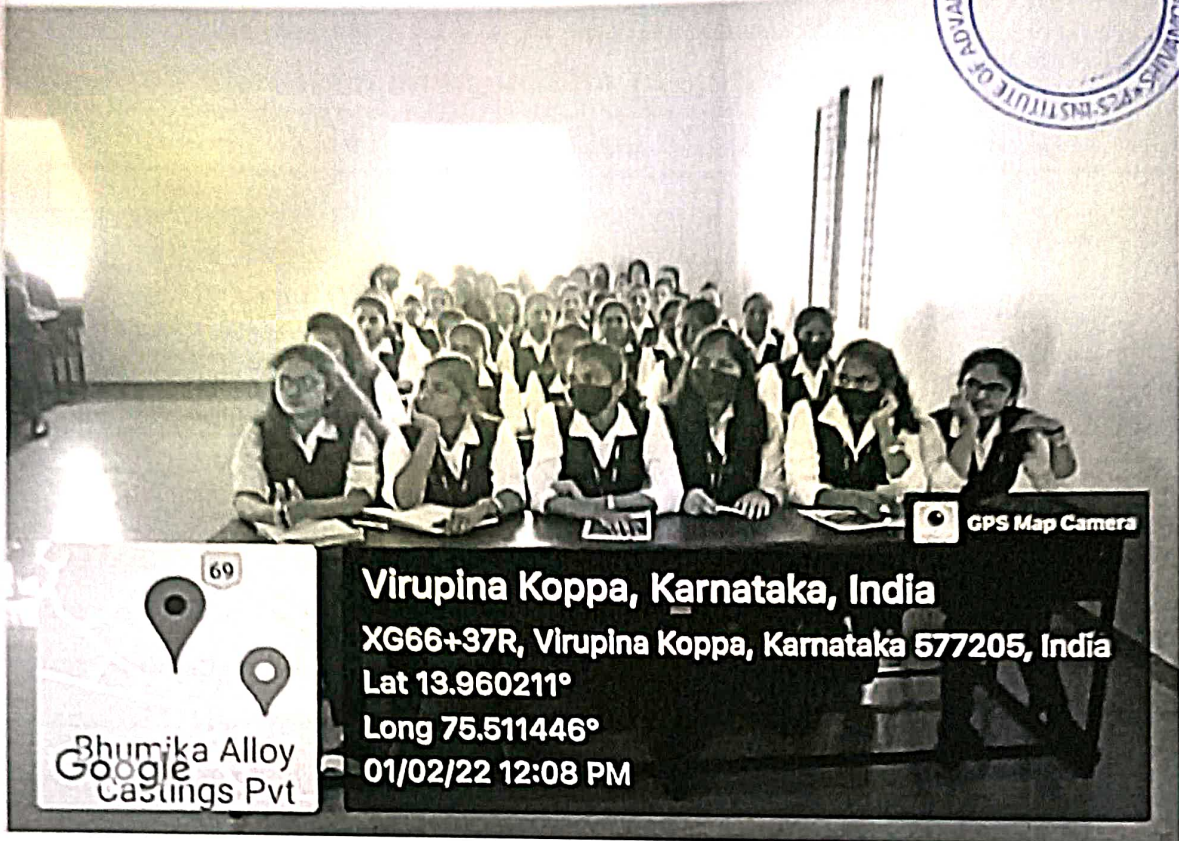

- 8 Million new dwelling in rural, urban areas to be completed under PM Awas Yojana.
- Rs. 2.37 trillion worth of MSP direct payments to wheat & paddy farmers.
